### 1. What is this product?

**Objectives** The product is designed to provide a return in the form of a cash payment on the maturity date. The amount of this payment will depend on the performance of the underlying. The product has a fixed term and will terminate on the maturity date. The payment at (Terms that appear in **bold** maturity will not exceed GBP 1.360.

On termination of the product on the maturity date you will receive a cash payment equal to (i) GBP 1,000 plus (ii) an amount directly in this section linked to the performance of the underlying. This amount will equal (i) GBP 2,000 (i.e., 200% of the product notional amount) are described multiplied by (ii) (x) (A) the final reference level divided by (B) the initial reference level minus (y) 100%. #### 2. What are the risks and what could I get in return?





The risk indicator assumes you keep the product for 6 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance of the **underlying** at a low level and the potential for us to be unable to pay you any amounts due as very unlikely.

You are entitled to receive back at least 100% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before maturity or in case of immediate termination by the issuer.

If we are not able to pay you what is owed, you could lose your entire investment.

This table shows the money you could get back over the next 6 years under different scenarios, assuming that you invest GBP 10,000. The scenarios shown illustrate how your investment could perform. #### 3. What happens if the manufacturer is unable to pay out?

#### 4. What are the costs?

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

### 5. How long should I hold it and can I take money out early?

#### **Recommended holding period: 6 years**

The product aims to provide you with the return described under "1. What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until 3 December 2027 (maturity).
